NOTE FROM OUR DIRECTOR IVOR CHIPKIN

South Africa is on the cusp of significant change, and the New South Institute (NSI) is at the forefront of this transformation. We have not only integrated ourselves into major think tank networks within South Africa through our work in institution-building but have also established ourselves as a global institute with strong links to leading universities.

I would also like to share that we have launched a new partnership with the Anti-Corruption Coalition (ACC), which builds on my work as co-author of the **Betrayal** of the Promise: How South Africa is being stolen report on state capture in South Africa and *Shadow State: The Politics of State Capture* (WUP: 2018) with Mark Swilling. The ACC is unit within the Centre for Business Ethics (CfBE), that aims to develop a comprehensive private database on corruption in South Africa to gain a thorough understanding of its various forms, support anti-corruption efforts through targeted research and analysis, and contribute to the global anti-corruption movement by sharing insights and learning from other countries facing similar challenges.

At the NSI, my colleagues and I have been focusing on innovative methodologies to measure state capture at organisations, using data modelling to enhance our understanding of this complex issue.

I am also honoured to announce that Dr Jelena Vidojević, co-founder of the New South Institute and project head for our South-South Dialogues and Rethinking the South African Welfare State programmes, has been appointed as a Research Associate at the Gordon Institute of Business Science (GIBS) for the next three years. At GIBS, she will continue her passionate work in these key areas.



in two sessions. On August 28th, she delivered a presentation titled, "Economic Progress: Reconstructing collective self-understanding in Chile and Spain".



State: The Curious Cases of Chile and South Africa".


The NSI has launched its latest research paper, An Analysis of Migration Governance Frameworks in Kenya. The report, by NSI research fellow Michael

It aligns with the NSI's focus on democracy and institution building by identifying policy gaps and offering recommendations to strengthen legal frameworks and inter-agency coordination. This publication plays an important role in fostering informed governance that supports both national and regional development within the broader African context, highlighting the crucial role of institutions such as the judiciary and Kenya's new constitution in establishing and improving migration governance. Adding to our growing series of seminal academic papers and intellectual discussions is an NSI working paper by Ivor Chipkin, co-authored with the University of Bristol. The paper, **Democracy**, power and evidence-informed policy-making: The Ccase of public service reform in South Africa, is part of a larger project examining the use of scientific evidence in policymaking. This paper calls for a balance between political control and administrative autonomy in South Africa's public service a key area for democratic and institutional reform.

ON CONTRADICTION ET AL.: OVERCOMING THE CRISIS OF GOVERNMENT IN SOUTH AFRICA

NSI'S IVOR CHIPKIN ADDRESSES SOUTH AFRICA'S PUBLIC SERVICE CRISIS IN NEW ACADEMIC ARTICLE

NSI's executive director and co-founder, Ivor Chipkin, in an article published in the Journal of Public Administration, studies the contradictions within South Africa's public service, **On Contradiction et al.**: **Overcoming the crisis of government in South** Africa.

In the academic article, Chipkin traces the roots of these issues to early post-apartheid legislation and presents a case for reforms that call for professionalism and accountability in public administration. This analysis is in line with the NSI's commitment to strengthening institutional frameworks to support democratic governance and effective public service delivery in South Africa. Read more here.



NAVIGATING CHALLENGES AND OPPORTUNITIES OF AFRICAN MIGRATION AND THE AFCFTA

In an article for the Brookings Institution, NSI researcher Alan Hirsch studied the role of personal mobility within the context of the African Continental Free Trade Agreement (AfCFTA). Hirsch's analysis explored Africa's shifting economic landscape, the challenges of implementing continental mobility protocols, and the valuable lessons that can be drawn from other regions.

The Brookings Institution is a nonprofit organisation based in Washington, D.C. The report looks at top priorities for Africa in 2023, examining the pressing policy issues on the continent in a time of heightened global turbulence.

THE END OF WAR: LESSONS FOR THE **FUTURE**

Sociologist, peace studies scholar and NSI researcher Radmila Nakarada participated at the Johns Hopkins SAIS Europe workshop Ending War: History, Theory, and Lessons, held from May 6 and 7, 2024, in Bologna, Italy. The workshop brought together scholars and policymakers to explore the complex process of war termination, with a focus on historical and ongoing conflicts.

Nakarada's contributions, particularly on the Yugoslav wars, provided perspectives on societal transitions and reconciliation processes. The event, co-hosted by leading academic institutions, aimed to merge historical analysis with strategic thinking, reflecting NSI's commitment to addressing global challenges through informed dialogue.

Nakarada will also be participating in the international conference Cooperative Multipolar System: In Quest for a New World Order, set to take place in October, in Skopje, North Macedonia.

NSI MEETS WITH PARLIAMENT'S NEW PORTFOLIO COMMITTEE ON PUBLIC SERVICE AND ADMINISTRATION



CONSOLIDATING THE AFRICAN CONTINENTAL **FREE TRADE AREA**



On 24 July, the Portfolio Committee on Public Service and Administration hosted an orientation meeting with the newly configured committee secretariat team. At this orientation session held in Parliament, Ivor Chipkin took the committee members through an introduction to public service in general, as well as its similarities and differences with public administration. The presentation then covered an analysis of South Africa's state of public service, also citing other similar cases internationally. He spoke of the five Cs of crisis in the SA context - contradiction (political/administrative), confusion (accountability), corruption/capture, weak capability, and centralisation. ALAN HIRSCH SPEAKS AT WESTERN CAPE PROVINCIAL PARLIAMENT'S STRATEGIC PLANNING SESSION

In July, the Western Cape Provincial Parliament's Administration undertook a Strategic Planning process for the new 5-year strategic period (2025/26 -2029/30). NSI senior researcher Alan Hirsch delivered a presentation at the planning session. His presentation highlighted South Africa's evolving political landscape, providing an understanding of the challenges for the upcoming strategic period.

LEADING THE DISCOURSE ON PUBLIC SERVICE REFORM TO STRENGTHEN DEMOCRACY

On 21 June, the NSI hosted a discussion on public service reform at the Donald Gordan Institute of Business Science (GIBS), our new home. The event also saw the launch of two policy papers authored by NSI director Ivor Chipkin together with researcher Rafael Leite, followed by a panel discussion with distinguished experts, including Rudi Dicks head of the Project Management Office in the Office of the President; Prof. Somadoda Fikeni Chairperson of the Public Service Commission; Leon Schreiber then Shadow Minister of Public Service and Administration and now Minister of Home Affairs; as well as Prof. Gerda van Dijk Director and Head of School of Public Management and Administration (UP). Maanda Tshifularo Director at the Centre for Leadership and Dialogue (CL&D) at GIBS, facilitated the discussion.

The reports advocate for a merit-based civil service and the implementation of the Professionalisation Framework to address the deep-seated challenges within South Africa's public service, such as contradiction, confusion, competence, centralisation, and corruption. Prof. Van Dijk highlighted the importance of viewing public service as a peoplecentric career, not just a stepping stone.



NSI'S PARTICIPATION IN OPERATION VULINDLELA

The NSI's Professor Alan Hirsch took part in the Building Momentum on Reform: Towards the Next Phase of Operation Vulindlela conference, held from June 25 and 26 in Johannesburg. Organised by the Presidency and National Treasury, the conference brought together policymakers, industry leaders and academics to evaluate the progress of Operation Vulindlela (OV), a joint initiative of the Presidency and National Treasury to accelerate structural reforms to uplift economic growth reforms.

Professor Hirsch participated in a panel discussion on visa reform where he highlighted the importance of improving South Africa's visa system to enhance migration governance and drive economic growth. The conference's discussions focused on key areas like energy, rail and water infrastructure, aiming to unlock further investment and efficiencies critical to South Africa's economic future.

EMPOWERING CIVIL SOCIETY TO TAKE **ON PUBLIC SERVICE REFORM**

On the 29th of July, 2024, the NSI, together with Defend Our Democracy, hosted a virtual briefing session titled Empowering Civil Society to Lead Public Service Reform. This event aimed to engage civil society on the ongoing amendments to the Public Service Act and emphasise their important role in these reforms.

Speakers included Ivor Chipkin, Yoliswa Makhasi Director-General of the Department of Public Service and Administration, and Neeshan Balton Executive Director at the Ahmed Kathrada Foundation. Chipkin provided historical context while outlining current initiatives. He also pointed to the importance of these changes for strengthening democratic governance and improving public service delivery. The event emphasised the need for civil society's active participation in shaping the future of public service in South Africa.

During an interview with South African talk radio station, POWER 98.7, Professor Alan Hirsch provided an analysis of South Africa's economic reforms over the past three decades. Drawing from his book, Season of Hope: Economic Reform under Mandela and Mbeki, Hirsch explored the optimistic beginnings of the Mandela presidency, and the subsequent challenges faced in governance and economic development.

Hirsch discussed the impact of various reforms on sectors such as education, infrastructure and public health, highlighting both achievements and areas where progress has stalled. His reflections offered critical understandings into the complex journey of South Africa's economy and the ongoing need for strategic policymaking to address inequality and drive growth.

NSI'S ADVOCACY FOR PUBLIC SERVICE REFORM

On the 21st of June, 2024, Ivor Chipkin, Executive Director of the NSI was on Newzroom Afrika, a premier South African 24-hour news and information service, to discuss public service reform. The interview highlighted the recent amendment to the Public Service Act, which the NSI strongly advocated for, aiming to shift power from politicians to senior officials in public service recruitment and operations.

Chipkin presented the NSI's latest reports, developed in collaboration with researcher Rafael Leite, which

provide a concrete action plan for public service reform. These legislative developments and NSI's ongoing efforts are important in rebalancing power within South Africa's public service, ensuring a more accountable and effective governance structure.



PUBLIC SERVICE REFORM

With more work emerging from our Public Service Reform programme, the NSI recently hosted a meeting in collaboration with the Public Service Commission at GIBS. The meeting was attended by representatives from the Presidency, the Public Service Commission, the Department of Public Service and Administration (DPSA), as well as leaders from civic organisations like the Ahmed Kathrada Foundation and Defend Our Democracy. The aim was to begin outlining a highlevel, consolidated reform programme. A report capturing the mood and discussions from the meeting will be developed.
